Your initials below each paragraph will indicate your understanding, agreement, and acceptance of each of the following TSC policies:

**Rental Fee Due Dates and Late Fees**: 100% of rental fees are due the day of pick-up of rental, or one week prior to shipment of costumes. Any late returns will carry a late fee of 1/3 of the original rental cost for each late week, or pro-rated per late day. At 30 days past due, costumes will be classified as "Missing" and will be subject to replacement charges as stated by TSC.

**Rental Fees:** Costume rental fees are assessed by the week. Each additional week of rental will be charged 1/3 of the original rental fee. Rental weeks start the day you pick up your costumes or the day your costumes arrive, if shipped. Please see attached inventory list for TSC rental fees. Most items will rent out for \$75/look.

Alterations/Damages: Costumes may be altered in ways that do not damage the integrity of the item. Prior to the return to TSC, the item must be restored to the condition in which it was rented. The renting company maintains financial responsibility for restoration or replacement of any costumes that are destroyed, disfigured, or that are returned damaged for any reason. Damaged or missing pieces of a garment, or pieces altered without TSC authorization, will require repair or replacement by the renting company. This charge can range from \$25.00 - \$500.00, depending on the costume. The renting company understands that no garment is to be cut in any way to accommodate alterations (including notching of altered seams). Other unacceptable alterations include dyeing, painting (including spray paint), gluing (including sticky-backed Velcro), and the removing of ornamentations or trims. Knee slides are not permitted by wearers while in a TSC costume. Any damage done to a costume due to knee slides will require a replacement charge for the entire costume. Do not mark a costume with tape of any kind. Safety pin a tag to the inside of the garment to mark it. Makeup that cannot be removed from a TSC costume will constitute permanent damage and will require full replacement charges. Stage blood is not to be used on or near TSC costumes. All alterations but be removed and costumes restored to original states prior to return to TSC. If you have a question about how a garment should be altered, cleaned, or repaired, call TSC's Costume Shop Manager. If you would like to make a major change to the costume that you think will improve it, call TSC's Costume Shop Manager to discuss first before any work is done.

**Costume pick-up and return**: Renting Company must make an appointment for TSC costume pick-up and/or return by calling the TSC Costume Shop Manager at (901) 759-0620, Monday through Friday, from 10:00 am - 4:00 pm, or by emailing Alexandria Perel-Sams at Alexperelsams@tnshakespeare.org. TSC's Costume Shop Manager or Resident Designer must be present at the time TSC's items leave/return to storage. TSC does not provide fitting space. Renting Company will need to send one person (costume designer), who will have the measurements, to go through TSC's stock. Renting Company is permitted to pull extra costumes for choices in fittings. Renting Company must bring back what is not used prior to its event date. TSC then will remove these items from the invoice. If you are unable to pull the costumes, TSC will pull them for you for a fee of \$40/hour.

**Cleaning Costumes:** Do not allow wearers of the costumes to eat or drink in or near TSC's costumes. Do not allow any perfume to be worn while in or around the costumes. TSC will clean the costumes with our cleaner. The price of the rentals will include this expense. If any scents or stains do not come out of the costume piece when it is dry-cleaned, that will constitute permanent damage and will require full replacement charges. During the run of your show or event, Vodka Spray may be used to clean and control any odor. Renting Company's wearers must wear "skins" when wearing TSC costumes. Do not use Febreze to deodorize costumes.

It is understood between both parties that this Agreement is made in Memphis, Shelby County, TN, and that Tennessee law shall govern the terms of this Agreement.
